

Application for the Issue of a Student Identification Card

Student Identification Card is, according to Section 57 of the Act No. 111/1998 Coll., On Higher Education Institutions, as amended, proof of studies issued by the Technical University of Liberec (hereinafter referred to as „TUL“), which confirms the student's legal status and entitles him/her to use the rights and benefits of the student according to legal regulations and internal regulations of TUL.

As stipulated by the above mentioned Act, TUL is authorized to process personal data of the student to the extent specified in this application.

For the purpose of issuing a student card in the ISIC variant, it is necessary to have the student's consent to the processing of his or her personal data in the extent specified in this application. Without the student's consent, the student will be issued a student card in the basic version without the possibility to make use of further student discounts and benefits associated with the ISIC.

Data Protection and Personal Data Management Guidelines

By signing this application for accommodation, I acknowledge the following information regarding the principles of protection and processing of personal data at TUL as listed above in this application:

The details provided by the applicant in this application are personal data within the meaning of Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of individuals with regard to the processing of personal data and on the free movement of such data and on repealing Directive 95/46/EC (the general regulation on the protection of personal data) - hereinafter "GDPR".

Personal data manager

The Technical University of Liberec, with its registered office at Studentská 1402/2, 461 17 Liberec 1, ID 6747885, is authorized to act as a personal data manager.

Personal data processor

The personal data processor in connection with the ISIC student card is GTS Alive, Ltd., IČ: 26193272, with its registered office at Prague 1, Letenská 118/1, postal code: 118 00, registered in the Commercial Register maintained by the Municipal Court in Prague in Section C, File No.16656.

Legal reasons for data management

TUL processes the personal data provided in this application for the purpose of issuing a student identification card pursuant to Section 57 (2) of Act No. 111/1998 Coll., On Higher Education Institutions, as amended.

The processing of personal data in connection with issuing the ISIC card for the purpose of granting international student discounts and benefits is performed on the basis of the consent given by the applicant for ISIC.

Scope of information and information management time

Personal data are processed to the extent specified in the application for the student's identification card and for the period of validity of the card and the following two years after the card's expiration.

Categories of personal data recipients

The provided personal data are managed directly by the appointed TUL staff and in the case of the ISIC student card, personal data are transferred and processed by GTS Alive Ltd.

Information on the rights of the data subjects

Data subjects have the following rights, provided they prove their identity:

1. Right to access the personal data (GDPR, Article 15) under which data subjects have the right to obtain from the TUL:
 - a. confirmation that the TUL manages their personal information,
 - b. information on the data management purposes, categories of data concerned, the recipients or categories of recipients of personal data that have been or will be made available, the scheduled time of data management, and data subjects' rights.
2. Right to correct inaccurate or incomplete data (GDPR, Article 16). Data subjects are also required to notify the TUL of any change in personal data and to prove that such a change has occurred, to provide the TUL with the necessary assistance if inaccuracies are identified in the data the TUL manages. The TUL will correct the data without undue delay, but with regard to available technologies.
3. Right to data erasure (GDPR, Article 17). If the TUL does not establish overriding legitimate grounds for the management of personal data, data subjects have the right to request their erasure. Personal data will be erased or anonymized without undue delay, taking into account available technologies.
4. Right to restrict the data management (GDPR, Article 18) if the data subjects deny the accuracy of personal data, the reasons and the purpose of processing, or oppose the processing thereof.
5. Right to notify the rectification, erasure of personal data, or restriction of processing thereof (GDPR, Article 19) by the TUL as a personal data controller, unless this proves impossible or requires unreasonable effort.
6. Right to portability of personal data (GDPR, Article 20) provided under consent or contract and managed by the TUL in a machine-readable format, including the right to obtain such personal data in a structured, commonly used and machine-readable format, and the right to request the TUL to transmit these data to another controller appointed by the data subject, if that is technically feasible.
7. Right to object to the management of personal data (GDPR, Article 21) processed for legitimate purposes of the TUL. The TUL shall no longer process the data unless it demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of data subjects or for the establishment, exercise or defence of the TUL legal claims.
8. Right to withdraw the consent to personal data management (GDPR, Article 7).
9. Right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects or similarly significantly affects the data subject (GDPR, Article 22). The TUL does not perform any fully automated decision-making without the influence of human judgment which would have legal or other significant effects on the data subjects.
10. Right to approach the Office for Personal Data Protection.
